You are strongly encouraged to participate in the AGM by voting on the Resolutions to be proposed at the AGM (the '**Resolutions**') by proxy ahead of the meeting and given the ongoing uncertainty around pandemic restrictions the Board recommends that you appoint me, as Chairman of the Company, as your proxy. To vote by proxy, please fill in the Form of Proxy sent to you with this document and return it, in accordance with the instructions given, to our registrars as soon as possible. They must receive it by 12 noon on Wednesday 15 December 2021. This letter is intended to help you understand the effect and purpose of the Resolutions.

Attending the AGM

We have sought to provide opportunities for shareholder engagement whilst observing our Articles of Association and considering any potential government-mandated coronavirus restrictions. We are pleased to offer shareholders a new, online AGM experience for the first time. As there remains uncertainty around the status of the pandemic the Board strongly recommends that shareholders do not attend the AGM in person. Instead shareholders are encouraged to join remotely via the webcast (joining details below). Please note that joining remotely will not constitute attendance and shareholders will not be able to vote at the meeting. Shareholders are therefore asked to submit their votes by proxy and are encouraged to do so by electronic means.

If you wish to attend the AGM in person and can do so safely and in accordance with the prevailing government guidance at the date of the meeting, please pre-register your intention to attend by emailing info@focusriteplc.com by 12 noon on Wednesday 15 December 2021. Please include your full name and Investor Code (IVC) in the email. In order to ensure the physical place of the meeting is safe, some additional measures may need to be introduced at the AGM, e.g. social distancing, face coverings and in-person attendance is subject to venue capacity constraints.

Shareholders and their duly appointed representatives and/or proxies are invited to join the AGM remotely via live webcast. Resolution 1: Reports and Accounts

The directors of the Company (the '**Directors**') are required to present to shareholders, at the AGM, the financial statements for the year ended 31 August 2021, together with the reports of the Directors (including the strategic report) and auditors thereon (the '**Annual Report**').

Resolution 2: Declaration of the final dividend

The Directors are recommending, and the shareholders are being asked to approve, the declaration of a final dividend of 3.7 pence per ordinary share for the year ended 31 August 2021. The final dividend will, subject to shareholder approval, be paid on 31 January 2022 to the holders of ordinary shares whose names are recorded on the Register of Members of the Company at the close of business on 31 December 2021.

Resolutions 3 to 8: Election and re-election of Directors

As was the case at each previous AGM, all the Directors will seek re-election.

In relation to the retirement and re-election of directors at its AGM, and whilst it is not subject to the provisions of the UK Corporate Governance Code (the '**Code**'), the board of Directors has determined that in line with the best practice recommendations of the Code, each of the Directors shall retire from office at the AGM. Each of the Directors intends to stand for re-election by the shareholders. Resolutions 3 to 8 relate to the re-election of the Directors.

Sally McKone was appointed to the Board on 1 March 2021. Accordingly, Ms McKone will offer herself for election at the AGM on Friday 17 December 2021. Resolution 5 relates to her appointment.

The biographical details of the Directors are set out on pages 56 to 57 of the Annual Report.

Resolution 9: The auditors

Company law requires the Company, at each general meeting at which accounts are laid, to appoint auditors to serve for the following financial year. Resolution 9 proposes to reappoint KPMG LLP as auditors of the Company and authorises the Directors to agree to the auditors' remuneration.

Resolution 10: Authority to allot shares pursuant to section 551 of the Companies Act 2006 (the 'Act')

The Directors may only allot shares and grant rights to subscribe for, or convert any security into, shares if authorised to do so by shareholders. Resolution 10 will be proposed as an Ordinary Resolution to grant new authorities to allot shares and grant rights to subscribe for, or convert any security into, shares up to an aggregate nominal amount of £19,553.88 (representing approximately 33.3% of the nominal value of the issued ordinary share capital of the Company as at 17 November 2021, being the last practicable date prior to publication of this notice.

Resolutions 11 and 12: Authority to disapply pre-emption rights pursuant to section 570 of the Act ('Special Resolutions')

The Directors also require authority from shareholders to allot equity securities for cash otherwise than to existing shareholders pro rata to their holdings. Resolutions 11 and 12 will be proposed as Special Resolutions to grant such authority.

Resolution 11 renews the Directors' power to allot equity securities in exchange for cash without first offering them to existing shareholders. Apart from rights issues or any other pre-emptive offer concerning equity securities, the authority contained in this Resolution will be limited to the issue of shares for cash up to an aggregate nominal value of £2,933.08. This number represents approximately 5% of the Company's issued share capital as at 17 November 2021, being the last practicable date prior to publication of this notice.

Resolution 11 also seeks a disapplication of pre-emption rights on a rights issue, so as to allow the Directors to make appropriate arrangements in relation to fractional entitlements or other legal or practical problems which might arise.

On 12 March 2015, the Pre-Emption Group ('**PEG**') issued a revised Statement of Principles ('**2015 Statement of Principles**'). This stated that, in addition to previous standard annual disapplication of pre-emption rights up to a maximum equal to 5% of issued ordinary share capital, the PEG was also supportive of extending the general disapplication authority by an additional 5% for certain purposes.

On 5 May 2016, the PEG published a monitoring report on the implementation of its 2015 Statement of Principles for disapplying pre-emption rights and a recommended template Resolution for disapplying pre-emption rights. The template recommends companies request authority to disapply pre-emption rights in respect of the additional 5% to be used when the Board considers the use to be for an acquisition or specified capital investment in accordance with the 2015 Statement of Principles as a separate Resolution to the disapplication to issue share on an unrestricted basis.

Resolution 12 seeks this separate and additional authority. The Directors confirm, in accordance with the 2015 Statement of Principles, that they will only allot shares representing no more than an additional 5% of the issued ordinary share capital of the Company for cash pursuant to the authority referred to in Resolution 12, where the allotment is in connection with an acquisition or specified capital investment, which is announced contemporaneously with the allotment. Where the authority granted under Resolution 12 is used, the circumstances that have led to its use and the consultation process undertaken will be disclosed by the Company in its next Annual Report.

The Board also intends to adhere to the provisions in the PEG's 2015 Statement of Principles and will not (except in relation to an issue pursuant to Resolution 12 in respect of the additional 5% referred to above) allot shares for cash on a non-pre-emptive basis pursuant to the authority in Resolution 11 in excess of an amount equal to 7.5% of the total issued ordinary share capital of the Company, excluding treasury shares, within a rolling three-year period, without prior consultation with the Company's shareholders.

The Directors have no present intention of issuing new shares other than pursuant to employee share plans, but the Directors consider that the authority sought is appropriate as it provides the Company with the necessary flexibility to take advantage of business opportunities as they arise.

Resolution 13: Purchases of own shares by the Company (Special Resolution)

Resolution 13 seeks authority from shareholders for the Company to make market purchases of its own ordinary shares, such authority being limited to the purchase of up to 5,866,164 ordinary shares (being approximately 10% of the Company's issued ordinary share capital as at 17 November 2021). The maximum and minimum prices payable are also limited in the Resolution. The authority will only be exercised if the Directors consider that there is likely to be a beneficial impact on earnings per ordinary shares and that it is in the best interests of the Company at the time. The Company will be able to hold the ordinary shares which have been repurchased as treasury shares and re-sell them for cash, cancel them or use them for the purposes of its employee share schemes.

If given, the powers in Resolutions 10 to 13 inclusive will expire after 15 months or at the conclusion of the AGM to be held in 2022 whichever is the earlier. As at the date of this notice the Company holds no treasury shares.

Recommendation

The Directors consider the Resolutions to be in the best interests of the Company and its shareholders. Accordingly, the Directors unanimously recommend shareholders to vote in favour of all the Resolutions.
